## REGIONAL MEETING JUDICIAL INDEPENDENCE IN THE AMERICAS: LISTENING TO JUDGES' VOICES

## Background

Judicial independence is one of the priority challenges related to strengthening democratic systems in the countries of the Americas. In an effort to address this topic, the Justice Studies Center of the Americas (JSCA) is organizing the regional meeting "Judicial Independence in the Americas: Listening to Judges' Voices" in collaboration with the Inter-American Commission on Human Rights (IACHR), the Latin American Magistrates' Federation (FIM), the Chilean Judges' Association and the World Justice Project, with the support of Global Affairs Canada (GAC).

## Context

The Justice Studies Center of the Americas (JSCA) recently developed its new 2022- 2026 Strategic Plan through a broad, inclusive and participatory process that involved 760 people who represent the justice institutions of the Americas, civil society, academia and international organizations.

Through the development of the aforementioned plan, a series of challenges faced by justice systems in the Americas were identified, including "...the role that they should play in the defense and strengthening of democracy in the region." (Our translation.) In effect, "...effective democracy requires independence of the various branches of government and respect for the rule of law." (Our translation.)

Although they recognize that justice systems and particularly judiciaries play a role in the defense and strengthening of democracy, the participants in the consultive processes that JSCA conducted also assert that "...there are internal and external threats to the independence of justice institutions that manifest on different levels and in different ways ranging from open and clearly illegitimate to subtle and veiled in a context of political polarization." (Our translation.)

There are two types of threats to judicial independence. The first is "external" threats including efforts to improperly influence judicial officials' appointment mechanisms or to limit or hinder the budgetary management of judiciaries. There are also "internal" pressures and risks within judiciaries that impact the professional careers of judges and other officials, including the selection, appointment, evaluation, confirmation and removal of judges.
