Emerging issues

To shed light on their specific situation and needs for access to justice from a gender and intersectional perspective, contributing to the generation of adequate and measurable responses from justice systems.

Increase the capacity to investigate, prosecute and effectively punish complex, serious, or transnational crimes, with emphasis on transnational organized crime and environmental crimes. In addition, to facilitate the exchange of good practices for the re-socialization of persons deprived of liberty, enforcement of sentences and social reintegration.

Promote justice institutions to develop a culture centered on the people they serve, encourage the adoption of open justice principles in these institutions, and support them in incorporating ICTs to deliver quality services.

Strengthen integrity and ethics in justice institutions to achieve greater transparency and accountability, with citizen participation and oversight, and contribute to processes of selection, appointment, evaluation, ratification, and accountability of justice operators, in accordance with international standards.

Identify specific topics that may be important on the current and future agenda of justice in the Americas.

Strengthen democracy and the rule of law in the Americas, participating in efforts to enhance independent, people-centered justice systems with greater capacities for managing and measuring their results.
